Prospect S – Q4, 2018 drilling




- All petroleum play elements proven by nearby drilling.
- Wells adjacent to Chariot acreage encountered excellent quality, oil-prone source rocks.
- Light oil (41° API) recovered adjacent to Central Blocks in reservoirs of the same age as some of Chariot's target prospects.
- Excellent quality Upper Cretaceous turbidite reservoir rocks encountered in Namibian deepwater wells, with a nearby well having good porosity and permeability at a similar depths as Chariot's targets.
- Orilling at the bottom of the cost cycle gross well cost 20 25 M\$
